## **DIRECTIONS (WOODBURY OFFICE)**

### **FROM PHILADELPHIA & WEST**

Start out going EAST on S PENN SQ toward S BROAD ST / AVENUE OF THE ARTS / PA-611.

Turn LEFT onto S JUNIPER ST. Turn RIGHT onto MARKET ST. Turn LEFT onto N 5TH ST.

Merge onto I-676 E toward I-95 N.

I-676 E becomes I-76 E.

Take the US-130 S exit- EXIT 1C- toward BROOKLAWN / WESTVILLE.

Merge onto I-295 S via EXIT 1A toward DEL. MEM. BR. / DELAWARE.

Merge onto NJ-45 S via EXIT 24A toward WOODBURY.

Turn LEFT onto E CENTRE ST.

End at 15 E Centre St Woodbury, NJ 08096-2415, US

### **FROM NEW YORK & NORTH**

Take the NEW JERSEY TURNPIKE South.

Take the RT-168 N exit- EXIT 3- toward CAMDEN / PHILADELPHIA.

Stay STRAIGHT to go onto S BLACK HORSE PIKE / NJ-168.

Merge onto I-295 S toward WALT WHITMAN BR / DEL MEM BR.

Merge onto I-76 E / I-295 S via EXIT 26 toward DEL. MEM. BR. / RT-42 SOUTH / ATLANTIC CITY.

Merge onto I-295 S via EXIT 1A toward DEL. MEM. BR. / DELAWARE.

Merge onto NJ-45 S via EXIT 24A toward WOODBURY.

Turn LEFT onto E CENTRE ST.

End at 15 E Centre St Woodbury, NJ 08096-2415, US

### **FROM BALTIMORE & SOUTH**

Merge onto I-95 N toward NEW YORK.

Merge onto I-295 N toward NEW JERSEY TURNPIKE / DEL MEM BR / NJ-NY.

Take the exit toward US-130 N / PENNS GROVE.

Merge onto I-295 N via the exit on the LEFT toward TRENTON.

Take the CR-640 W exit- EXIT 21- toward CR-534 JCT / NATIONAL PK / WOODBURY.

Take the ramp toward CR-534 E / WOODBURY.

Stay STRAIGHT to go onto DELAWARE ST / CR-640. Continue to follow DELAWARE ST.

Turn RIGHT onto S BROAD ST / NJ-45 / CR-551. Turn LEFT onto E CENTRE ST.

End at 15 E Centre St Woodbury, NJ 08096-2415, US
